**RESOLUTION 2017-1
ADOPTION OF THE
DOWNTOWN TROY PLAN – VISION 2026**

WHEREAS, Downtown Troy is a distinct location that provides retail shopping, entertainment, governmental and professional services, housing, and other amenities in an historic setting in the heart of the City of Troy; and

WHEREAS, the Troy Planning Commission and Troy citizens recognize the importance of the unique opportunities found in Downtown Troy that cannot be duplicated in other locations of the city; and

WHEREAS, the Troy Planning Commission, working in concert with City staff, solicited input from the public, and from that input developed a vision for the future of Downtown Troy; and

WHEREAS, extensive studies were conducted and various community meetings, surveys, polls, and recommendations were considered to compile the Downtown Troy Plan – Vision 2026 to serve as a guide for creating a unified vision for continued development and economic growth in the downtown area; and

WHEREAS, all requirements of the laws of the State of Alabama with regard to preparation, discussion and review of said Downtown Troy Plan – Vision 2026 have been met;

NOW THEREFORE BE IT RESOLVED by the Planning Commission of the City of Troy, Alabama that the document entitled the *Downtown Troy Plan – Vision 2026* and all official maps and illustrations pertaining thereto, are hereby adopted, subject to any revisions, changes or modifications approved as part of this resolution and final edits as required for final printing of the plan and certified by the Troy Planning Commission Secretary; and,

BE IT FURTHER RESOLVED that the Planning Commission does hereby recommend to the City Council of the City of Troy, Alabama adoption of the *Downtown Troy Plan – Vision 2026* to create a unified vision for the continued development and economic growth of the downtown district.
